RELEASE OF LIABILITY—READ BEFORE SIGNING

For participants 18 years old

In consideration of being allowed to participate in any way with the use of rafting equipment owned by Camp Deerpark, its related events and activities, I, the undersigned, acknowledge, appreciate, and agree that: The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular skills, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,

I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF CAMP DEERPARK or others, and assume full responsibility for my participation; and,

I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of Camp Deerpark immediately; and,

I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND INDEMINFY, AND HOLD HARMLESS CAMP DEERPARK their officers, officials, agents and/or employees, other participants sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used for the activity (“Camp Deerpark”), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property associates with my presence or participation, WHEATHER ARISING FROM THE NEGLIGENCE OF CAMP DEERPARK OR OTHERWISE, to the fullest extent permitted by law.
